	assessment needed to be made under the Environmental Information Regulations Act 2004, and
	that maps of the properties are held on the GIS system which they are happy to show the clerk

	details. Every single time (over 16 days) when I have attempted to submit my report, the website has crashed and buffered for 4 minutes, before issuing a "something is up, but don't worry, the website probably just needs a slight configuration, the problem has been logged" message appears. The problem has not however been logged as I have not been issued with any reference numbers or confirmations. I have gone through this process many times. I have also been unable to get a response to the telephone calls I have made, and attempts to again report the potholes yesterday ended exactly the same way.
