Chairman Grant requested that thanks be extended to all who distributed the village questionnaire alongside the Parish News. It was agreed to hold an Extra-Ordinary General Meeting on Monday 12th March at 8pm to agree a response to the planning applications from Stansted Airport Limited - UTT/18/0460/FUL - Airfield works comprising two new taxiway links to the existing runway (a Rapid Access Taxiway and a Rapid Exit Taxiway), six additional remote aircraft stands (adjacent Yankee taxiway); and three additional aircraft stands (extension of the Echo Apron) to enable combined airfield operations of 274,000 aircraft movements and a throughput of 43 million terminal passengers, in a 12-month calendar period. <b>Meeting closed at 21.45</b>
